As well as original prints by over 48 well known architectural photographers like Morley Baer, Robert T. Brandeis, Joshua Freiwald, Leo Holub, Nathaniel Lieberman, Moulin Gabriel Studios, Rondal Partridge, and Gerald Ratto.

Warnecke Institute gives non-exclusive permission for images that can be used for specific publications and not for anything else. Requests including your proposed use must be made in writing to the Warnecke Institute to obtain a release for images.

The Warnecke Architectural Archives, upon approval of a written request, will consider consent to a <u>one-time use</u> of photographs as the owner of the physical items; however, this DOES NOT include or imply permission from the photographer's copyright.

Such permission must be obtained from the copyright owner, heir(s), or assigns.

"Courtesy of John Carl Warnecke Architectural Archives" must be indicated below the image each time the image appears in the publication.

The Warnecke Architectural Archives retains all copyrights to images.

Copyright Notice

The Copyright Law of the United States (Title 17, United States Code) governs the making of photocopies or other reproductions of copyrighted material. Under certain conditions specified in the law, libraries and archives are authorized to furnish a photocopy or other reproduction.

- 1. Visitors agree that photographs are for personal study purposes only and may not be reproduced, donated, published, exhibited, nor sold to another repository.
- 2. Fragile, damaged, or restricted items will not be duplicated in any way.
- 3. Personal scanners, tripods, camera flashes, extension cords, and special lighting are prohibited without permission.
- 4. Appropriate care and handling of any archive materials
- 5. The order of materials must be maintained at all times.
- 6. Visitors are responsible for complying with copyright law.
- 7. Visitors must acknowledge that it is their responsibility to obtain relevant permission from copyright owners in the event that they decide to publish their work.
- 8. Images for publication or distribution must be ordered by submitting a request and signing our Image Use Policy and Associated Fees.

The Warnecke Archives reserves the right to deny photography requests and/or to revoke photographic privileges for any reason.
